# Presidents Report- Marnie Kerridge

"Advocating for what you believe in is crucial. If you don't ask for it, people assume you don't need it."

This quote aligns itself with Deaf Victoria's motto "Nothing about us, without us". Without the deaf community and individuals, Deaf Victoria cannot work to improve the things that affect your access, your equality, your wellbeing. Systematic advocacy is a big part of our work.



#### **Hospital Interpreting Inquiry:**

The work to improve access continues and Deaf Victoria in included in an advisory capacity in this area. Deaf Victoria continues to work closely with Victorian Equal Opportunity and Human Rights Commission and other organisations to follow through with implementing the recommendations in the report.

#### **Mental Health Conference:**

Following our Mental Health panel at Deaf Victoria's AGM last year, it was noted that there was a need for further support and advocacy in this area. In conjunction with Karli Health Centre, Deaf Victoria was part of a steering group to deliver a Mental Health Conference in November 16<sup>th</sup> and 17<sup>th</sup> of this year. The conference aims to do a "from the ground up" approach, aiming to educate the system and professionals about the needs, barriers and issues faced by the grassroots community. Following a successful application for funding from Mental Health Australia where the maximum amount was granted, the steering group comprises of Melissa Lowrie, Gary Kerridge, Karli Dettman, Sandra Spadea, Sherrie Beaver and Dean Barton-Smith. Deaf Victoria thanks the steering group for their work and involvement and is sure the conference will be a success. We also thank all the sponsors for their support leading up to and during the conference.

#### **Deaf Market**

In March, Deaf Victoria once again hosted their annual Deaf Market day. This was well attended with many stall-holders peddling their wares. DSRV and DSA participated by running sporting events and raffles were held to support various causes by different deaf organisations. Thanks to Melbourne Deaf Cricket Club for the use of their facilities on this day.

#### **WFD**

Melissa Lowrie's application to present on "An Inquiry Into Access Into Interpreting at Victorian Hospitals" was accepted by the World Federation of the Deaf Congress, held in Turkey, and in June she presented on behalf of Deaf Victoria. The worldwide exposure was invaluable and Melissa brought back much knowledge and awareness, as well as giving some back herself to the worldwide Deaf community. Deaf Victoria are very proud of her efforts.

#### **DA Forum**

Deaf Australia announced some significant changes to their membership structure and a new scheme called the Deaf Friendly Scheme. Deaf Victoria decided to host a community forum so that this scheme and membership structure could be more clearly explained to the community. #### DV Membership / Constitution meeting

In July, Deaf Victoria held a constitution meeting and to discuss membership pathways. With the changes to Deaf Australia's constitution and membership, there was a follow on effect to Deaf Victoria's constitution. A group of about 20 community and Deaf Victoria members participated and agreed consensus occurred over several points, which will shape our new constitution, if approved at the next AGM. Some significant changes include allowing hearing members onto the Board and two separate membership structures.

#### **Deaf Youth Victoria:**

Deaf Youth Victoria continues to work hard and making their name known to the community. They held a successful camp in Torquay in February and have been seen in the community doing various fundraising events. Deaf Victoria has supported them in developing their vision and goals for the future.

#### Facebook and Website:

Deaf Victoria's new website, launched last year, continues to impress with its new look and better design. Facebook is used extensively also to communicate news and events with the community. At the end of May we received 1000 likes. Currently we now reach 1,170 people via Facebook, not including any shared posts.

#### Staff

Deaf Victoria staff are Melissa Lowrie and Melanie Merhi. Congratulations to Melanie Merhi on acquiring her TAE thus making her able to conduct Deaf Deaf World Workshops. Responses from her work in DDW has been very positive and it is pleasing to see an increase in requests as a result. Melissa continues to positively enhance Deaf Victoria's name with her systematic and individual advocacy work. Both are the 'face' of Deaf Victoria and do an exemplary job, often going above and beyond the call of duty. They are a credit and a valuable asset to Deaf Victoria. Thank you both.

# Managers Report - Melissa Lowrie



Dear Members and Friends,

Its been a jam packed 2015, with lots of fantastic results for the Deaf community and hard of hearing people. We knew it would be a fantastic year for Auslan, on Australia Day when Western Australias Drisana Levitzke-Gray was awarded Young Australian Of the Year. Never before has Deaf people and Auslan been up in lights in this way before, and for that, I congratulate Drisana for the hard work she did this year!

In Victoria, we kept up the momentum and did our bit for the Victorian community too. Here are some of the highlights of 2015:

#### Website

At the 32<sup>nd</sup> Annual General Meeting, our outgoing President, Simon Glass, launched our new Deaf Victoria Website which is up and running now at www.deafvictoria.org.au

#### Mental Health and Deaf people

At the 32<sup>nd</sup> Annual General meeting, Deaf Victoria hosted a panel on mental health and deaf people. This was fantastic, and from this we started the ball rolling to actively start Deaf Victoria's next systemic project for 2015. Deaf Victoria, with the support of Gary Kerridge, Dean Barton Smith, Karli Dettman and Sandra Spadea, applied to Mental Health Australia for a grant of \$20,000 to host a national mental health conference to be held in Melbourne on 16-17<sup>th</sup> November 2015 at Deakin University in Burwood. Alongside this, Deaf Victoria and Gary Kerridge commenced a short research project, based on a survey collating the experience of deaf and hard of hearing consumers and carers of people with a mental illness accessing the mental health system. With the outcomes of the survey and the outcomes of the conference, Deaf Victoria will create advocacy goals to do systemic advocacy work around developing a community-based response to mental health for deaf and hard of hearing people. Deaf Victoria also submitted a paper contributing to Victoria's 10 year strategy for Mental Health.

#### Membership

For the last 12 months, Deaf Victoria has been consulting with the Victorian community regarding what they want from their membership with Deaf Victoria, in light of the membership changes passed by Deaf Australia in November 2014.

# Victorian Auslan Training Consortium (VATC)

Deaf Victoria is involved in the biannual VATC Meetings, updating on the progress of the Auslan Training program delivered by Melbourne Polytechnic. We are pleased to report that the number of Auslan learners has grown and continues to meet set targets.

#### **State Government Elections**

In November 2014, Victoria went to the polls to vote for our State Government, and Colleen Hartland MP partnered with Deaf Victoria and ASLIA Victoria to create a groundbreaking Auslan version of a Q & A for voters. Deaf Victorians were able to ask questions via social

Deaf Victorians were able to ask questions via social media and have them answered by MP Hartland on video with the assistance of an Auslan Interpreter. This was a fantastic initiative by The Greens party and was received very well by the community.

#### Victoria Police Disability Reference Group Meeting

Deaf Victoria attends and contributes to quarterly meetings with Victoria Police Disability Reference Group.

#### **Hospitals Project**

Deaf Victoria works regularly with the Victorian Equal Opportunity and Human Rights Commission, Department of Health and Human Services and Vicdeaf around the recommendations of its Inquiry into Access to Auslan Interpreters in Victorian Public Hospitals report. Some of the key themes being discussed this year include:

- Lack of staff awareness and training in knowing what the laws/ obligations are
- The ability of the Deaf person to make a complaint via the correct channels and factors affecting this
- Inconsistent knowledge around costs and how to book interpreters on all levels of hospital staffing
- Providing interpreters in emergency
- Technology and its role in Video Relay interpreting and health services
- Ethics and boundaries, as well as appropriate qualification of interpreters used in health services
- Concerns from all groups about hospital staff not understanding the needs and motivations of Deaf
  patients- i.e.: Why deaf people have/ need preferred interpreters

There are many things still happening in these spaces that are positive and productive.

#### World Federation of the Deaf- Istanbul, Turkey

Melissa Lowrie presented on behalf of Deaf Victoria on the "Inquiry into Access to Auslan Interpreters in Victorian Public Hospitals" to the attendees of the World Federation of the Deaf in Istanbul Turkey, on 31<sup>st</sup> July 2015. The presentation was very positively received.

#### **Aboriginal and Torres Strait Islander training**

On Saturday 29th November 2014, a number of Deaf Victoria staff, board and Deaf Youth Victoria board undertook cultural training by Deaf Aboriginal, Jody Barney. This was very positively received.

#### **Deaf Market**

Deaf Market came and went for another year and it was a very successful and enjoyable community event. Deaf Victoria partnered with Deaf Sports and Recreation Victoria, and Melbourne Deaf Cricket Club- it was fantastic to see people from all over Victoria attend and enjoy the day playing cricket, having a try at different sporting activities and enjoying the crafts on sale by the Deaf community.

#### **Gaslight Festival**

Deaf Victoria attended the Gaslight Festival in Wodonga, Victoria, on 7-8<sup>th</sup> March 2015 to provide an "On-the Spot" Advocacy service. It was an enjoyable weekend and proved to be very effective, as clients were pleasantly surprised to realize that they could quickly sort out their issue or leave their information with me to follow up. Clients enjoyed the convenience and we look forward to doing more of this.

#### Assistive Technology for Deaf and hard of hearing people Workshop

Deakin University invited Deaf Victoria, along with Auslan Services, Word of Mouth Technology, Bradley Reporting and Senswide services to assist in a workshop aimed at people who are deaf and hard of hearing about to leave school and enter the workplace about what technology is available to them. Deaf Victoria's role was to explain their rights in the workplace, how to be assertive and advocate for themselves and the job access scheme. This workshop was very beneficial and we look forward to delivering this again.

#### **National Transport Commission**

Deaf Victoria continued work with the National Transport Commission on changing the guidelines for hearing assessment of Deaf truck drivers. The amendment was successful and set to be released for comment at the end of 2015.

# **Deaf Deaf World**

Deaf Victoria delivered a number of Deaf Deaf World Workshops this year, and have changed the format of the workshop to be easily customized to different groups. This has proved successful and we look forward to doing more of this.


## Victoria Hearing Marketing Campaign
